- Studying or enrolled on a level 3 programme OR
- Have achieved a level 3 qualification in Health and Social Care in the last 12 months

Entrants for this Skills Competition Wales can be any age however entrants should be aware that for the WorldSkills competition there is an upper age restriction.

Competition outline

The competition consists of three activities:

Activity 1: Complete paired role play activity: up to 30 minutes

Activity 2: Individual task: up to 15 minutes

Activity 3: Multiple choice questionnaire: up to 15 minutes

Activity 1:

You are a domiciliary care support worker who visits older service users in their own home. One of your clients is Mrs Jones, a 70-year-old lady who has had a stroke. As a consequence, she takes medication for her condition. She lives alone. Working in pairs, you are going to assist Mrs Jones with her morning routine, taking into account her individual needs.

Activity 2:

At the end of activity 1 there will be an individual task involving some routine observations. This activity will include a reflection and evaluation session with the judging panel.

Activity 3:

A multiple choice questionnaire for the entrants to complete.

The detail

This is a one-day competition. All contestants will need to attend a short Health and Safety (housekeeping) briefing at registration on the date of the final.

Competitors, in pairs, will be involved in activity 1 (role play). Competitor pairs will be determined on the day. Students from the same provider will not be able to compete as a pair.

Competitors will be expected to deal with issues as they arise, using the knowledge and understanding they have of how to assist and support individuals with the defined condition(s).

During activity 2 competitors will individually be required to carry out and record data from individual routine observations. They will be required to explain and provide supporting rationale for their performance. Competitors will be asked to reflect on the performance of their pair and their own contribution. They should comment on their strengths and weaknesses during the role play and how the pair could perform better in the future.

The multiple choice questionnaire and the reflection activity following the role play will be taken individually by each competitor. The multiple choice questionnaire will contain some general questions relating to theory and policy relevant to the sector.

Providers can register, using the online registration system, for a maximum of three places. Places allocated will be confirmed after the registration deadline.

Marking and assessment

Marking and judging of this competition will be undertaken by a team of qualified experts from industry, further education or training providers. The assessors will use a predetermined set of marking criteria against which marks will be awarded.

Competition rules

Those wishing to enter this competition should be:

- Studying or enrolled on a level 3 programme OR
- Have achieved a level 3 qualification in Health and Social Care in the last 12 months.

Entrants for this Skills Competition Wales can be any age however entrants should be aware that for the WorldSkills competition there is an upper age restriction.

Bydd cystadleuwyr yn cymryd rhan yng ngweithgaredd 1 (chwarae rôl) mewn parau. Bydd y parau o gystadleuwyr yn cael eu cadarnhau ar y diwrnod. Ni fydd myfyrwyr o'r un darparwr yn gallu cystadlu fel pâr.

Bydd disgwyl i'r cystadleuwyr ddelio â materion wrth iddyn nhw ddigwydd, defnyddio'r wybodaeth a'r ddealltwriaeth sydd ganddyn nhw o sut i gynorthwyo a chefnogi unigolion gyda'r cyflwr/cyflyrau sydd wedi'u diffinio.
