Health & Social Entry – towards Level 1

The competition is for learners working towards Level 1.

Competitors must be 16 years of age or over who have completed a selection process through their home region.

#### Competition outline

The Health and Social Care competition is designed to allow learners to demonstrate their understanding of Infection Control in the environment. Learners will display their comprehension of the importance of infection control procedures and why they have to be followed in Health and Social Care settings.

Competitors will be shown a simulated bedroom used by an elderly person, they will then need to:

- Put on the correct personal protective equipment they would wear for carrying out a personal care task on an elderly person
- Remove soiled linen from the service users' bed and select the correct colour coded bag to place this in ready for transporting to the laundry.
- Dispose of the personal protective equipment appropriately
- Complete a hand washing procedure prior to if they were to be carrying out a personal care task on an elderly person

- Complete a multiple choice task summarising their understanding of infection control procedures. Individuals will have 10 minutes to read brief and ask questions to clarify. Then a further 20 minutes to complete the tasks.

### Competition rules

Marks will be awarded within the objective judging criteria:

- Competitor is dressed appropriately & uses preparation time to clarify and review simulation.
- Competitor shows an understanding of infection control procedures.
- Competitor completes the multiple choice task and shows a positive understanding of infection control.
- Competitor uses appropriate language, spelling, punctuation
- Competitor completes task in allocated time
