

Popular Music Competition

Level 2/3 Brief

Entry Requirements

This competition is aimed at learners who are part of a band. They will be working towards or have achieved a Level 2 or 3 musical qualification (or equivalent). Please note:

- a maximum of one group may enter per organisation.
- all band members must be enrolled with the FE organisation.
- this is a Skills Competition Wales event. There is no opportunity to progress to the UK Skills Show in Birmingham.

Competition Outline

You will have 20 minutes stage time, so please ensure your set is a maximum of 15 minutes. Points will be deducted for going over the time allocated. The band line up must consist of two or more members. There is no limit on band size however the competition host will contribute a financial sum for accommodation to a maximum of 7 competitors. Consideration must also be given to set-up and stage times.

Competitors are required to select, rehearse and perform a short set of three songs. The songs can be cover versions, original compositions, or a combination of both. We hope to stream the event live as much as possible through the Facebook page www.facebook.com/SgiliauCyfryngauaChreadigol/. Only original content will be broadcast during the event or included on the page after the event. It is important to note that this is not a song writing competition therefore any original compositions will be marked on exactly the same criteria as the cover songs (please see below). **No additional marks will be awarded for composing.**

Your first song will provide an opportunity for a sound check. You will be judged on your best two songs.

It is important to select or compose songs that enable you to fully achieve the specific grading criteria set as seen overleaf.

You may perform the songs in the style of your choosing but please be aware you are performing at a live public venue. Any inappropriate behaviour and/ or offensive language will need to be edited from the performance. It is the responsibility of staff to ensure that students adhere to this ruling.

A **Technical Specification** sheet will be sent out to the colleges after registration. It is vital that this is completed in advance of the competition to facilitate each band's technical requirements and smooth running of the day. There will also be an additional form sent out prior to the event asking for track listings for PRS purposes. This will also be an opportunity for bands to give information about themselves as well as make clear to the judges what they are trying to do in terms of Market (Aspect ID E).

Marking and Assessment

The songs will be performed live in front of a panel of judges. The judges will assess each performance against the criteria outlined below:

Aspect ID	Description	Max Mark
A	Musicality & Technical Accuracy e.g. ability to reproduce accurate rhythm and pitch, techniques consistent with style and content with regards to genre, timing, tone, intonation, phrasing, articulation, expression, tightness, beginnings and endings	10
B	Stagecraft and awareness e.g. selection and effective application of appropriate performance aesthetic, choreography (movement), balancing of the stage, blocking of movement, posture, attitude and delivery, setting up, time management	10
C	Ensemble skills e.g. musical interaction, unity as an ensemble (being 'in the pocket'), differing time signatures, stabs, runs, stops, harmonies, instrumental techniques, control of ensemble and individual dynamics	10
D	Arrangement and Selection e.g. effective use of ensemble resources, original and inventive arrangements, use of unusual time signatures or syncopation, extended or alternate harmony, balance and appropriate use of dramatic effect, contrasting selection of songs	10
E	Market awareness and originality e.g. selection of appropriate repertoire and contemporary treatment, understanding of arranging for live performance, appropriate visual presentation, original arrangement and performance, original instrumental parts and vocal interpretations.	10

The above criteria will have allocated marks per aspect. Below is an indication of the grading benchmarks.

- 1 - Unacceptable work
- 2 - Very weak work
- 3 - Weak work
- 4 - Below basic work
- 5 - Basic work
- 6 - Average work
- 7 - Good / Commendable work
- 8 - Very good work
- 9 - Excellent work
- 10 - Outstanding work

Once marks have been awarded by each of the judges, they will be averaged to obtain the final mark. A panel of independent judges will be selected and is the responsibility of the host organisation. The judges' decisions will be moderated and quality assured by Coleg Menai.

Core Competencies

The scope of the competition enables learners to develop and put into practice a variety of skills that are required to be a working musician within the industry.



Competitors taking part in this competition should be able to:

- Play an instrument or sing to an advanced level
- Understand the technical operation and maintenance of their instrument and appropriate contemporary sound generation
- Be able to apply genre specific performance and arranging techniques
- Understand and apply appropriate performance aesthetics and stage craft
- Work collaboratively and communicate effectively
- Solve problems and meet challenges using practical and creative skills
- Demonstrate innovation in musical performance and arrangement
- Proactively manage disciplined personal practice

Conduct for competitors during live competitions:

- Competitors will perform live, three songs of their choice
- Competitors who arrive late will not receive additional time unless a valid reason is given
- Competitors will start and finish work as instructed by the judges
- If there is a power stoppage, breakdown of equipment or accident, the competitors must act according to the instruction of the organiser
- The use of inappropriate and offensive language in songs will need to be edited for the performance
- The panel's decisions will be quality assured by Coleg Menai before the winners are announced.



Anfonir ffurflen ychwanegol allan cyn y digwyddiad, i ofyn am restr draciau i bwrrpas PRS. Bydd ymryd hela dyddiadol a cymru fandiau roi gwybodaeth amdanyst eu hunain yn ogystal ag egluro i'r beirniaid o'r maenaw a ceisio'i wneud o ran y Farchnad (Agwedd ID E).


