Competition title and level

Enterprise Skills Challenge Competition. Up to Level 3

Entry requirements

This competition is intended for teams who are working towards a Level 2 or Level 3 qualification within a programme of study at a 6th form college in Wales

- Maximum of 1 team of up to 5 learners per college (teams must be registered on the Skills Competitions Wales portal <https://www.skillscompetitionwales.ac.uk/> by October 20th 2018)
 - All learners must be enrolled within the organisation

Please note that this is a Welsh competition and it does not currently lead to the UK competition, or an international competition

Competition outline

Centres will run internal heats (passives) to choose a team to represent them at the final.

Teams submit a business plan, marketing plan and cash flow forecast for their innovative idea via email to enterprise@Cambria.ac.uk by 19th January 2019. Submissions will be held in Google Drive folders under the Business name (not College/School names). Team members should be named at this point on the accompanying email (plus gender and ages given).

Team submissions will be shared with judges on 26th of January via Google folders (identifiable by Business name only)

On the day of the competition (1st of February 2019) teams will be given 1 hour to address a ‘wobble’. The ‘wobble’ is likely to be something that is in the external environment, which is beyond their control but could have a potential positive or negative impact on their business idea.

They will be required to complete a form on how they intend to address the ‘wobble’ which will be submitted to judges to be judged.

Team will have 5 minutes to pitch their idea to a panel of judges followed by 5 minutes of question and answers.



The detail

Challenge Brief

Wales is working towards becoming a Circular Economy – a model which encourages keeping resources in circulation instead of them being burned or ending their life in Landfill.

Wales already leads the way in the UK on recycling rates but it has a long way to go to reach its milestones of 70% recycling by 2025 and 100% recycling by 2050, as set out in the Welsh Government's waste strategy [Towards Zero Waste](#).

In a world where resource prices are rising fast, the circular economy model has the potential to provide significant cost benefits for Welsh businesses as well as saving the economy money and creating jobs. However these targets are a long way in the future, what can you do to make a difference now?

Your challenge is to: identify a plastic product that you use regularly and develop a business idea to re-use the plastic. Your idea could be for a product which re-uses the plastic and extends the life of the material or creates a new life for the plastic. You could alternatively develop a service to reduce the use/increase the re-use plastic products.

Judges will be looking for influence on the business idea from your subject area/of study as well as ideas on how you would market/advertising your product or service.

Whilst it is important that your business idea can make money, the winning idea will not be the one which could make the most money. Judges will be looking for the idea which has the biggest impact on the environment, its creativity as well as the economic benefits for Wales.

- The panel's decisions will be quality assured by Coleg Cambria before winners are announced.

- Arddangos cymhwysedd digidol


